#### **1. Qualification**

Anyone over 16 years of age who resides within the Community Council boundary area can stand for election. All that is required is that the candidate, proposer and seconds' names appear on the Electoral Register. (Alternative measures for identification and residency status of candidates may be undertaken in certain circumstances)

#### **2. Vacancies**

There are currently **5** vacancies being advertised for Langside, Battlefield and Camphill Community Council.

#### **3. Closing Date**

Valid nomination forms must be submitted to Glasgow City Council (see below) by Friday 28<sup>th</sup> November 2025.

#### **4. Filling Vacancies**

- ***Uncontested Election Meeting:***

Should **5** or fewer valid nominations be submitted to Glasgow City Council, the candidates will be elected unopposed on Tuesday 2nd December 2025 at 7pm in Finn's Place, 167 Ledard Road, Glasgow, G42 9QU.

- ***Contested Election – Secret Ballot:***

Should more than **5** valid nominations be submitted to Glasgow City Council by Friday 28<sup>th</sup> November 2025, a secret ballot will take place in Finn's Place.

**Contested Election**

If more than **5** valid nominations are received by the closing date then a secret ballot will take place on date TBC in Finn's Place, 167 Ledard Road Glasgow, G42 9QU.

3. All persons aged over 16 years and resident in the Community Council area are entitled to vote in elections.
  4. All proposers and seconders must also be resident in the Community Council area and aged over 16 years.
  5. Candidates, proposers and seconders names should appear on the Electoral Register (alternative measures for identification status of candidates may be undertaken in certain circumstances).

**Term of Office**
